I will be responsible for setting up and removing my exhibit and garbage.

Any vendor arriving to set up past the allotted set-up time will not be permitted to drive into the Festival area and will therefore not be allowed to drive to their pre-assigned space. I will then be responsible to transport my items by foot and there will be no refund for lost time.

I understand that all vendors are independent agents. I will comply with New York State Law that requires sales tax to be collected.

I shall and will hold harmless the Cold Spring Harbor Merchants Association and Nightingale & Nightingale, Inc. and its members from and against any and all claims, liabilities, demands, expenses, fees, penalties, suits, proceedings, actions and causes of action of any and every kind and nature arising from or out of, or in any connected way with vendor use, occupancy or activities in or related to the Howl-ween taking place October 29, 2011 (rain date: October 30, 2011). Vendors will be personally liable to other participating vendors and members of the public for their own acts.

I understand that neither Cold Spring Harbor Merchants Association and Nightingale & Nightingale, Inc. nor its members will be held responsible for loss and/or damage to vendor's personal property caused by any reason and I will not assert any such claim against them.

The Cold Spring Harbor Merchants Association and Nightingale & Nightingale, Inc. reserves the right to decline acceptance of any application or to ask any vendor to leave the festival if they have misrepresented information on this application, or if their product or conduct is deemed inappropriate to this family-oriented event.
